Research reference: a sourced comparison for directors weighing Credicorp Loan against cash reserves, supplier terms and the wider Credicorp product family.

This .org record is kept for citation and due diligence. It records the product or cash-flow question, the public sources checked, and the boundary between research and customer service.

Professional fees can bunch around filing, tax, contract or compliance deadlines. The decision is easier when the company writes down the invoice, the date and the repayment source.

Keep the adviser paid where the work protects the company record or unlocks a contract. The sources below show the rule, product page or public register behind the point.
