

# Credicorp product comparison: Open Banking Consent product-routing guide

Research reference: a sourced product-routing guide for comparing Credicorp Loan, Credicorp Flex and Credicorp Slice when open banking consent affects cash flow.

This .org record is kept for citation and due diligence. It records the product or cash-flow question, the public sources checked, and the boundary between research and customer service.

Open Banking evidence can make cash-flow checks clearer, but consent and data use still need to be understood. The first check is whether the cost is dated, evidenced and likely to clear from a known receipt.

Only use read-only consent that the business understands and can revoke. The links below are the source checks used for this page.
