

Credicorp product comparison: Trade Credit director note

Research reference: a sourced director note for comparing Credicorp Loan, Credicorp Flex and Credicorp Slice when trade credit affects cash flow.

This .org record is kept for citation and due diligence. It records the product or cash-flow question, the public sources checked, and the boundary between research and customer service.

Trade credit is useful only when the company can meet the terms it accepts. Treat the borrowing as a job to be done, not as extra revenue.

Do not turn every supplier into a lender. Compare the cost of credit, late payment and a formal facility. The citations make the route auditable without copying source text.
